Dear Mr. Kelley,

We have been notified by the bank that the recent check (#5077) for your annual license renewal in the amount of \$150.00 was returned for non-sufficient funds.

Please read below the excerpt from our statute regarding NSF checks.

§312

1. Causes for nonissuance, suspension, revocation, or restrictions; fines; reinstatement

A. The board may refuse to issue or may suspend, revoke, or impose probationary or other restrictions on any license issued under this Chapter for any of the following causes:

(12) Failing for a period of seven calendar days after notice is given to make good a check which has been returned for insufficient funds (NSF check) or bank draft remitted to the owner or consignor of auctioned goods in settlement pursuant to R.S. 37:3125.

Acts 1983, No. 508, §5; Acts 1986, No. 564, §2, eff. July 2, 1986; Acts 1990, No. 895, §1, eff. Jan. 1, 1991; Acts 1997, No. 923, §1.

As the statute states, you have 7 calendar days to make a new payment via money order or cashier's check to the board office for \$150 + \$25 NSF charge for a total of \$175 or your license will be suspended.

If payment has not been made and you hold an auction past the 7 calendar days, you will be violating the Auctioneer's Licensing law and may subject to you monetary fines in addition to suspension.
